- 1. The fire walk is being managed by a third-party organiser BLAZE who reserve the right to cancel or stop a fire walk if there is a sign of potential dangers.
- 2. Anyone aged 14 and over can take part in the fire walk though those aged 14 & 15 will require parental/guardian consent and be accompanied by an adult aged 18 or over.
- 3. Upon registering you will be asked to provide an emergency contact name and number for someone who will be available on the day of the event who is not also taking part in the Firewalk.
- 4. The event is covered BLAZE Certificate of Insurance.
- 5. St. Michael's Hospice strongly advises all participants to take out their own insurance to cover themselves for all aspects of the event.
- 6. St. Michael's Hospice cannot accept liability for any property you may lose or damage during this event.
- 7. Participants must follow instructions given by the event organisers, Hospice staff, volunteers or medical personnel throughout the duration of the event. Failure to do so may result in exclusion from the event.
- 8. The registration fee is non-refundable and non-transferable.
- 9. If the weather changes and should the event need to be modified, postponed or cancelled you will be notified as soon as possible.
- 10. You are responsible for your own medical condition. If you are in any doubt about your health or have a medical condition that could be affected by this activity, we kindly ask you to obtain your doctors approval before participating in the event. You take part at your own risk.
- 11. Alcohol and drugs are NOT permitted at the event.

- 15. St Michael's Hospice reserves the right to update its terms and conditions in relation to the event at any time prior to the event. All participants will be provided with any updated terms and conditions in advance of the event or on the day itself.
- 16. We will plan to run to the timings detailed in your confirmation details though these may need to be adjusted slightly as to the requirements of the organising company on the night.
- 17. Participants acknowledge the sharing of their personal data to relevant third-party event suppliers for insurance purposes. If you are registering a child under the age of 16, you agree for us to store their data until the event is complete. You also agree for us to share that date with third parties where appropriate.
- 18. Parking is not available on the Hospice grounds for this event, parking is available within the Basingstoke & North Hampshire Hospital car park.
- 19. Capacity limits this event at 50 participants.
